पारंपरिक प्रतिस्पर्धी भारत-पाकिस्तानदरम्यान आज लक्षवेधक लढत मधल्या षटकांतील खेळ केंद्रस्थानी

पीटीआय, कोलंबो

शक्य-अशक्यतेच्या हिंदोळ्यावर झुलत राहिलेल्या भारत-पाकिस्तान या पारंपरिक प्रतिस्पर्ध्यांमधील ट्वेन्टी-२० विश्वचषक क्रिकेट स्पर्धेतील लढत अखेर आज, रविवारी प्रेमदासा मैदानावर पार पडेल. सामन्यावरील वर्चस्वासाठी मधल्या षटकांतील कामगिरी आणि षटकांचा खेळ महत्त्वाचा ठरणार असून, या सगळ्यावर वरुणराजाची कृपा आवश्यक असणार आहे.

चर्चेच्या अनेक फेऱ्या, अनेकांची मध्यस्थी आणि पडद्यामागील अनेक घडामोडींनंतर यंदाच्या विश्वचषक स्पर्धेतील हा सामना प्रत्यक्षात आला आहे. संपूर्ण दक्षिण आशिया हा सामना घडवून आणण्यासाठी प्रयत्नशील होता. हा सामना निश्चित झाला असला, तरी तो खेळला जाणार की नाही हे देवावर अवलंबून राहणार आहे. हवामानतज्ज्ञांनी पावसाचा अंदाज वर्तवला असून, आता वरुणराजावरच या सामन्याची देरी आहे. लांबीचा वारंवार आणि बॅकेतील शिल्लक या दोन्हींना आकर्षित करण्याची ताकद या सामन्यात आहे.

सामन्यापूर्वी घडलेल्या सर्व प्रसंगांना विसरून जाऊन दोन्ही संघांतील खेळाडूंनी आणखी एक सामना असे म्हणत या सामन्याबाबत सुरू असलेल्या मैदानावरील आणि बाहेरील चर्चेला पूर्णविराम देण्याचा प्रयत्न केला आहे. खेळाडूंची मनःस्थिती आणि त्यांची विचारशक्ती यांचा मेळ घालणे सध्या तरी खूप कठीण आहे. दोन्ही संघांवरील खेळाडूंचा सारखेच दडपण आहे. निकाल विरोधात जाऊ नये असे दोन्ही संघांना वाटत आहे. त्यासाठी मैदानाबाहेर सुरू असलेल्या चर्चा आणि घडामोडींना नजरअंदाज करून खेळाडूंना मैदानावर खेळाकडे लक्ष केंद्रित करावे लागणार आहे.



पाकिस्तानची फिरकीवर अधिक मदत

पाकिस्तान संघ कोलंबोत दोन सामने खेळला आहे. भारत पहिलाच सामना खेळणार आहे. पाकिस्तानला येथील खेळपट्टी आणि परिस्थितीची चांगली ओळख झाली आहे. खेळपट्टीवर वेगवान गोलंदाजांना अभावानेच साथ मिळत आहे. फिरकी गोलंदाजांना मदत करणाऱ्या या खेळपट्टीवर आपले कसब दाखविण्यासाठी पाकिस्तानकडे उस्मान तारिक, सैम अयुब, अब्दुल अहमद, शादाब खान, मोहम्मद नवाज असे पाच फिरकी गोलंदाज आहेत. तारिकची गोलंदाजी शैली आधीच चर्चेचा विषय बनली आहे. त्यामुळे वैविध्य असलेल्या भारतीय फलंदाजांना आपले कौशल्य पणाला लावावे लागेल यात शंका नाही. दुसरीकडे फिरकी गोलंदाजीबरोबर तेवढ्याच तगड्या भारतीय गोलंदाजीसमोर उभे राहण्यासाठी पाकिस्तानच्या बाबर आझम, अयुब, फखर झमान, साहिबझाद फरहान, अष्टपैलू फहीम अश्वक या प्रमुख फलंदाजांना चमक दाखवावी लागेल.

हस्तांदोलनाबाबत अजून मौन

भारताविरुद्ध होणारा सामना ज्या भावनेने खेळला जायला हवा त्याच भावनेने खेळला जावा अशी अपेक्षा व्यक्त करत पाकिस्तान संघाचा कर्णधार सलमान आघा याने व्यक्त केली असली, तरी येथील वातावरण लक्षात घेता हस्तांदोलनाबाबत अद्याप मौनच बाळगले गेले आहे. सामन्यापूर्वी झालेल्या पत्रकार परिषदेत मैदानावरील कामगिरीपेक्षा हस्तांदोलनाचे काय ? असा प्रश्न वारंवार विचारला जाऊ लागल्यावर सलमान आघाने आपणे ते सामन्याच्या वेळी पाहू एवढीच प्रतिक्रिया व्यक्त केली. खेळभावनेने हा सामना खेळला जावा इतकेच आपले म्हणणे असल्याचे आघाने सांगितले.

पावसामुळे खेळखंडोबा ? श्रीलंकेच्या हवामान विभागाने बंगालच्या उपसागरावर कमी दाबाचा बिंदू तयार होण्याचा इशारा दिला आहे. त्याचा सर्वाधिक परिणाम खेतारामा परिसरावर होण्याची शक्यता असून, सुमारे ७० टक्के पावसाची शक्यता वर्तविण्यात आली आहे.

शर्मांच्या उपलब्धतेपासून सुरुवात होते. पोटाच्या आजारांमुळे त्याला पहिल्या सामन्यात खेळता आले नव्हते. त्याच्या उपलब्धतेविषयी अजूनही काही सांगण्यात आलेले नाही. त्यामुळे त्याच्या जागी संजू सॅमसन किंवा तंदुरुस्त झालेल्या वॉशिंग्टन सुंदरला खेळविण्याचा पर्याय भारतीय संघ व्यवस्थापनापुढे असेल. यातील ज्या कोणाची निवड होईल, तो इशान किशनचा सलामीचा साथीदार असेल, यावर संघ व्यवस्थापन ठाम आहे. प्रेमदासा स्टेडियमची खेळपट्टी संघ आणि काहीशी चिकट असल्यामुळे फिरकी गोलंदाज हा उत्तम पर्याय ठरणार यात शंका नाही. याच मैदानावर शुक्रवारी ऑस्ट्रेलियाला पराभवाचा सामना करावा लागला होता. तेव्हा झिम्बाब्वेच्या नवख्या फिरकीबरोबर व्हेसिंग मुझराबानी याची मध्यमगती गोलंदाजी निर्णायक ठरली होती. खेळपट्टीचे स्वरूप लक्षात घेता भारतीय संघ व्यवस्थापन कुलदीप यादवला खेळविण्यासाठी प्रवृत्त होऊ शकते. मात्र, यासाठी भारताला एका फलंदाजाला वेगळ्याच लागेल. कुलदीपला खेळविण्याचा निर्णय झाल्यास रिंकू सिंहवर गदा येईल.

मार्को यान्सनच्या (४/४०) भेदक गोलंदाजीनंतर कर्णधार एडीन मार्करमच्या (४४ चेंडूंत नाबाद ८६) आक्रमक अर्धशतकाच्या जोरावर सरस दक्षिण आफ्रिका संघाने शनिवारी ट्वेन्टी-२० विश्वचषक क्रिकेट स्पर्धेतील सामन्यात न्यूझीलंडचा सात गडी राखून पराभव करताना 'ड' गटातील वर्चस्वाच्या लढाईत बाजी मारली.

न्यूझीलंडला टिम सेफ्ट (१३), रचिन रवींद्र (१३), ग्लेन फिलिप्स (१) लवकर बाद झाल्यानंतरही फिन अॅलन, मार्क चॅपमन, डॅरेल मिचेल यांच्या आक्रमक पवित्र्याने वेगवान वाटचाल केली होती. सोळाव्या षटकापर्यंत त्यांच्या डावाची गती नऊच्या आसपास राहिली होती. अर्थात, अॅलन (१७ चेंडूत ३१) आणि चॅपमन (२६ चेंडूत ४८) यांनी
